The "Dr. Graham's Homes, Kalimpong" Society

MEMORANDUM OF ASSOCIATION

1. The Name of the Society is the "Dr. Graham's Homes, Kalimpong."
2. The objects for which the Society is established are:—
 - (a) To provide Christian education and training based on Protestant Principles (through the medium of English), as may fit them for life as useful citizens of India for children of the Anglo-Indian Community of India provided that 40% of the annual admissions shall be made available to children of Communities other than the Anglo-Indian Community.
 - (b) To purchase, take on lease or in exchange, hire, or otherwise acquire any real or personal property and any rights and privileges necessary or convenient for the purposes of the Society, and in particular any land, farms, easements, buildings, machinery, plant and livestock.
 - (c) To purchase or otherwise acquire any Stock Funds or Securities of the Government of the United Kingdom or India or of any other British possessions and also any Stock, Shares, Share Warrants Scrip, Debentures or Securities of or in any Joint Stock or other Company, Corporation (Municipal or otherwise) Society or Association in India or elsewhere.
 - (d) To construct, maintain and alter any school buildings, workshops, farm or other buildings necessary or convenient for the purposes of the Society.
 - (e) To sell, improve manage, develop, lease, mortgage, dispose of, turn to account, or otherwise deal with all or any part of the moveable and immovable property of the Society.
 - (f) To borrow or raise money upon mortgage or in such other manner as the Society shall think fit.
 - (g) To do all such other things as are incidental or conducive to the attainment of the above objects.
